2. Public Comments:

No members of the public brought any comments for items not on the agenda.

3. Consent Agenda:

Meeting Minutes, March 13, 2018 meeting and April 24, 2018 special meeting.

A motion was made by Paton and seconded by Benton to approve the March 13, 2018 and April 24, 2018 meeting minutes as written. Voice vote carried the motion.

4. Hold a public hearing to consider the preliminary plat of Carver Park

Rogers called for a motion to open the public hearing. A motion was made by Benton and seconded by Paton to open the public hearing. Voice vote carried the motion. White presented the findings of the case. This is a minor plat that involves one lot. Cowley College wishes to develop student housing on this property. He mentioned traffic would need to be studied to ensure safe access in the area. This item of discussion will be held by the Technical Advisory Committee. Brown asked about the current use. White said it was used as a practice field. Jennings also added how the area had been used including as the segregated pool at one time. He also inquired about the floodplain. White indicated that was certainly a concern shared by staff and would have to addressed prior to any construction. Brown also asked about parking and White indicated there would be plenty of room to put proper parking for the residents. Jennings expressed some concern about stormwater runoff. White indicated a drainage plan would be required for the development. Cheri Hulse with Agora Architecture pointed out the concept had been completed a few years ago and stated proper studies would be conducted as part of the site development. Johnnie Davis of 105 S 8th St stated he had no major concerns about the development and felt the canal would adequately handle the runoff from it. A motion was made by Paton to close the public hearing and was seconded by Jennings. Voice vote carried the motion. Paton made a motion to approve the preliminary plat of Carver Park. The motion was seconded by Benton. Brown had some concerns about relations between the college and the city including some past agreements that he felt were not properly met. Planning Commissioners felt staff should follow up with his concerns but that most of the concerns should be addressed to the City Commission. Jennings called the question. Vote was taken by roll call.

5. Consider the final plat of Carver Park
